How it Works

Example: If John and Jane Doe¹ contribute \$400 to the District for support of extra curricular activities (without specifying the contribution for any particular student), and John and Jane Doe are in the 28% tax bracket having itemized deduction, they would save \$512 on their Federal and State tax returns for this year. That's right; you can save \$512 in taxes for a \$400 contribution to Clarkdale-Jerome School!

State tax savings-	\$400
Federal Tax savings (Charitable Contribution of \$400 at 28%)	\$112
Total tax savings	\$512
Amount contributed	\$400
