VIII. Information and Discussion Items

A. 2021-'22 Accountability Label (Letter Grade)

Superintendent Brown shared the 2021-2022 Accountability Label-Letter Grades with the Board. In the Spring of 2021, our students took the AASA. This is the 3rd different test in the last five years. Clarkdale-Jerome Elementary School earned a 'B' letter grade. These letter grades are based on a 100 point system. 30 points from Student Test Scores, 50 points from Student Growth, 10 points from ELL Proficiency and Growth and 10 points from Acceleration and Readiness. Factors such as chronic absenteeism, the number of students in the 3rd grade ELA Minimally Proficient category and the number of students in the 8th grade Math Minimally Proficient category will affect the Acceleration and Readiness points. Scores are also broken into categories such as Ethnicity and SPED Inclusion which can earn up to 10 points. CJES is the 6th highest ranking in Yavapai County and we earned the highest ranking letter grade in the Verde Valley.
