A. Town of Clarkdale General Plan Presentation

Ruth Mayday, Town of Clarkdale, spoke with the Board regarding the Town of Clarkdale's General Plan. The General Plan is a document the Town of Clarkdale is required to produce every ten (10) years by State law. It sets goals for the community for the next ten years. The Town has been working on it for the last eighteen (18) months. It is now available on the Town website for review. It will then go to the Planning Commission in August, the Town Council in September and then out

to the Public for ratification and approval. Community members are asked to submit any concerns, changes or comments to the Town before it goes for final approval. The General Plan has fourteen (14) elements such as Education, Parks & Recreation, Historical Preservation and Economic Development. The Town of Clarkdale is addressing the need to find affordable housing in the area. They are also working with Cottonwood and Sedona. She stated the Arizona Commerce Authority and USDA have programs to help first time homebuyers. She then asked for questions or comments. Janet Regner stated she would like to see language in the Plan to include our Yavapai-Apache Nation as part of our education community. She would also like to see data on the demographics and social economics of the education community and she feels that the General Plan needs to include more information regarding our community college.
